



STEP Fund - Small Business Grant for Exporting

Promoting your company at trade shows can be an effective way to gain recognition in your industry and to enter into the global market or expand your international trade capabilities. But not every small business is in the position to coordinate trade show logistics or design and operate their own trade booth. The Oklahoma Department of Commerce makes it possible for Oklahoma companies to partner with the state at trade shows across the globe. With the help of the Oklahoma STEP Fund, qualified companies can get reimbursed for 75% of the participation cost.

Funded Services

The STEP Fund is a matching grant reimbursing 75% of costs for three different designated services: participation costs and travel expenses to exhibit at international trade shows, cost of Export Compliance Training, and Export Solutions through US Commercial Services.

For all shows, matching grant reimbursement for exhibitor passes and travel costs (airfare and hotel) is capped at two people per company per show.

Eligibility Requirements

To be eligible, an applicant must own a small Oklahoma-based business which: (1) is organized or incorporated in the United States; (2) is operating in the United States; (3) has been in business for not less than 1 year, as of the date on which assistance is provided using this grant; (4) Has access to sufficient resources to bear the costs associated with trade, including the costs of packing, shipping, freight forwarding, and customs brokers; (5) in good business standing; and (6) complies with SBA size standards 13 C.F.R. Part 121.

Use of Funds & Grant Requirements

The recipient must use the grant specifically for exhibition at designated export trade shows and the travel costs associated with the show.

Travel reimbursement will cover airfare and lodging only. Oklahoma STEP Fund will reimburse 75% of the cost. The maximum varies for each show.

Application Process

Companies can apply for funds for one or more these services. Events each have their own application deadlines.

Companies must meet certain eligibility requirements in order to secure funding for trade shows. Grants are funded through a reimbursement process.

Export Solutions

Through a partnership with U.S. Commercial Services, (part of the U.S. Department of Commerce's International Trade Administration), we are offering companies a full range of expertise in international trade. Learn how to export, connect with foreign buyers, handle trade challenges and expand operations in new markets. Commerce's Trade Team has identified the following 3 services as qualifying STEP grant activities:

Gold Key Services

Provides U.S. companies with matchmaking appointments with up to five interested partners in a foreign market. The full service includes identification and outreach to potential matching firms, sending client's information to identified matching firms, preparing a profile of interested firms, attending the appointments and providing a report with the profile and contact information for interested firms.

International Partner Search

Provides U.S. companies with a list of up to five partners/distributors that have expressed an interest in the client's goods/services. The service includes identification and outreach to potential matching firms, sending client's information to identified matching firms, preparing a profile of interested firms, and providing a report with the profile and contact information for interested firms.

Due Diligence on Foreign Parties

The International Company Profile provides U.S. companies with in-depth background check information on a specific foreign company to help determine its suitability as a potential business partner. The service includes interviews with principals/references, a comprehensive background report on a specific foreign company and analysis of information collected.
