## ERDA Annual Members Meeting April 13, 2023 Minutes

CALL TO ORDER: Kyle Williams called the ERDA annual member's meeting to order at 11:45 a.m. and welcomed attendees to ERDA's annual members meeting and quarterly luncheon.

MINUTES: Minutes from the previous annual meeting of April 14, 2022, were presented for approval. Motion by Todd Earl and second by Chris Jones was unanimously approved with voting cards raised. There were no voting cards raised in opposition to the motion.

We will recognize our outgoing board member, Dave Lamerton with Hanor at our October luncheon. Kyle Williams also reminded the board that Jerald Gilbert, Manager for the City of Enid and Jon Blankenship, Executive Director of Greater Enid Chamber both serve as ex-officio members of the ERDA Board of Directors.

Kyle Williams introduced the Keynote Speaker, Secretary of Transportation, Tim Gatz. Secretary Gatz updated the audience on efforts at ODOT and safety measures for everyone to adhere to stay alive while on Oklahoma's roads.
