#### **ERDA Members and Stakeholders,**

As I reflect on the last 12 months as Chair of this organization, I find myself grateful for the many partnerships ERDA has in this community. It is often hard to quantify the results of Economic Development efforts, but with the assistance of the City of Enid, the Greater Enid Chamber of Commerce, ERDA's Business Members, our educational institutions, Main Street Enid, Visit Enid and others, much has been accomplished.

ERDA has focused on business retention and expansion, business recruitment, workforce attraction, retail development and quality of life objectives in Enid. Recruiting new business and industry to Enid and the surrounding area is a large piece of ERDA's strategic plan. This year we've had announcements of two new manufacturing plants coming to Enid that will result in hundreds of new jobs paying above the county's average median wage. We've also celebrated with two long-term Enid manufacturing plants as they've expanded their operations, added jobs, and increased sales. These companies are mentioned in more detail within the pages of this annual report.

ERDA has been instrumental in assisting area high school students with scholarships as they work towards their private pilot's license. Introducing careers in aviation and aerospace to high school students has proved very successful. Feeding the job pipeline to aviation related businesses in Enid, including Vance Air Force Base contractors, is a part of this initiative. ERDA was awarded an Industry Partnership Grant to help support these programs.

Retail development and entertainment venues have been major areas of focus for ERDA. Work is ongoing to bring new retail opportunities as well as a new entertainment venue to Enid enhancing our quality of life. Knowing the amount of work going on behind the scenes, we can anticipate great things coming to our community.

As we continue to work together, I believe we will continue to be the best place to live, work and grow in Oklahoma!

## **COMMUNITY INVESTMENTS**

ERDA supports existing Enid companies to make sure they are heathy and growing by connecting them to a variety of resources to find funding and meet workforce needs.

#### **ADVANCE SOCCER COMPLEX**

Advance Soccer Complex broke ground in August 2021. What is noted as the most significant privatepublic partnership in Enid's history is expected to open in the fall of 2023. The complex has seven full-size fields, a clubhouse, and a playground. The Advance Soccer Complex is top-notch. For example, the astroturf on the main field is the same as the Dallas Cowboys play on at AT&T Stadium in Texas.

#### **KAW LAKE PIPELINE**

The new water treatment plan for Enid continues under construction. When completed, the facility will gather the raw water from Kaw Lake and blend it with existing well water, and distribute it through the City. The \$313 million Kaw Lake Water Project will diversify and increase Enid's overall water supply.

#### **BRI-STEEL**

Bri-Steel announced they are opening a state-ofthe-art facility in Enid that produces large diameter seamless steel pipe. They will hire 50 employees at startup and plan to grow quickly adding another 50-75 employees at full capacity.

#### RENEW

Renew broke ground on their new remanufacturing facility in Enid. Renew is leading the way in wind power maintenance. The Enid plant will be a premier gearbox and mainshaft repair center providing premium service with fully upgraded components. Hiring will begin soon with 50 jobs initially with the potential to employ approximately 100 at full production.

#### РТ

PT is expanding to provide increased stainless-steel capacity. Their new foundry opened recently just across the street from their longstanding facility and foundry. Their growth will take them into new markets and allow them to continue serving customers around the world.

#### THE DISTRICT

Great Plains Bank recently opened their new location in The District. They joined Hideway Pizza, Jiffy Trip and Colten's Steakhouse in The District. ERDA and their retail consultant, Rickey Hayes, has been working alongside the City of Enid and community partners to bring additional tenants to The District to fill the retail gap of clothing, soft goods, technology, and entertainment.

#### **AVIATION AND AEROSPACE**

ERDA supports the state's second largest industry, aviation and aerospace in various ways. The Aircraft Owners and Pilots Association (AOPA) STEM curriculum "You Can Fly" has taken off at both Chisholm High School and Enid High School with just under 100 students enrolled in the program that promotes, develops and fosters the next generation of aviation professionals in Oklahoma.

#### **IMPACT PARTNERSHIP GRANT**

Through an Impact Partnership Grant awarded by the Governor's Council for Workforce and Economic Development and the Oklahoma Office of Workforce Development, ERDA convened a group of Aviation and Aerospace professionals as well as K-12 and Higher Education leaders to work towards promoting careers in aerospace including maintenance and repair as well as pilots. The goal is to develop a pipeline for existing aviation support careers. Highlights of this year's program include scholarships awarded for aviation gas expenses to high school students enrolled in flight school along with financial support to Northern Oklahoma College for their Summer Aviation Camp for Junior High students.

#### **ROBERT M. GREER CAMPUS**

The new Robert M. Greer campus construction is nearing completion. The facility will ensure that Enid continues to offer quality care for dually diagnosed clients.

#### UNDER CONSTRUCTION

The Sears Loft Apartments are under construction inside the former Sears Department Store in Enid. The store was built in 1927 and is being remodeled into very nice one and two bedroom apartments. Retail and office space will be provided on the first floor. Remodeling a historic building is not for the faint of heart, Gary Dezarn, building owner and developer would tell you. This will be a great addition to the downtown Enid community. More people living downtown result in increased activity, stores, bars and restaurants staying open later increasing the Quality of Life in Enid.

#### NOW OPEN!

With a grand opening on May 4, 2023, Sidwell Distribution quickly became a prime redistribution location for the northwest part of the state and beyond. The warehouse location contains a dry warehouse, refrigeration, and freezer storage. There is space available for other storage needs too. They currently make deliveries and pickups in Oklahoma City and Tulsa and are excited to expand their reach throughout Oklahoma. Bringing other businesses owned by Brady Sidwell under one roof made the move simply make sense!

## FY 2022-2023 ASSISTANCE PROGRAMS

#### **EQUIPMENT PURCHASE**

The Equipment Purchase program helps pay for equipment that will increase efficiency for a company by enhancing sales with less expense or adding a new product line to the company.

#### **INFRASTRUCTURE ASSISTANCE**

Businesses who require new, repaired, or improved public infrastructure to serve their location (road, water, sewer, broadband) may qualify for assistance. Infrastructure must be for infill development only and may not extend the boundaries of existing City utilities.

#### **SMALL BUSINESS RENOVATION**

This program assists with renovation costs to owned or leased space. Funds are provided as a reimbursement to renovate, expand, or redesign a commercial, retail, or industrial space.

#### **MICROENTERPRISE GRANT**

The MicroEnterprise Grant is an annual competitive grant utilizing Community Development Block Grant funds and matching contributions by ERDA. Two \$10,000 awards were granted this year.

#### DOWNTOWN SPRINKLER PROGRAM

The Downtown Sprinkler Program assists with costs for fire suppression and sprinkler systems for new and expanding businesses in Downtown Enid.

#### ENID SUMMER INTERNSHIP PROGRAM

In partnership with Northern Oklahoma College-Enid, ERDA assists local businesses with housing for college students in Enid for summer internships. ERDA Business Members receive housing for their summer interns free of charge. For others, there is a minimal fee. This housing opportunity for summer interns is limited to 10 loft apartments on NOC's Enid Campus. This program has been very successful with summer interns moving to Enid, OK after they graduate from college to take jobs here. Trent Misak and Clayeton Hammock, CPA are just two of our success stories from the ESIP program. Both moved from their hometowns after receiving their college degree to begin their professional careers in Enid.

#### **GROUNDBREAKING ASSISTANCE**

ERDA is glad to loan 10 small gold shovels for business groundbreaking ceremonies. ERDA Business Members may receive up to 6 long-handled engraved shovels to commemorate the event. Businesses that are not members of ERDA will pay a fee for the commemorative shovels.

#### **JOB FAIRS**

Businesses new to Enid or current Enid businesses expanding their operations and in need of additional employees, may request ERDA's assistance with a Job Fair. 
