**CALL TO ORDER:** The meeting was called to order by Matt Parrish at 10:04 a.m. A quorum was present.

**MINUTES JULY 18, 2023:** Minutes of the rescheduled regular meeting on July 18, 2023 were considered for approval. Motion by Tom Evans with second by Todd Earl to approve the minutes as presented, passed unanimously.

**IPG AVIATION UPDATE:** Debbie Moore updated the board on recent activity related to the Industry Partnership Grant for Aviation and Aerospace workforce development. Aviation gas scholarships of \$2500 each were awarded to 7 students taking flight lessons and currently enrolled in the AOPA programs at either Enid High School or Chisholm High School. Debbie also reported the grant funds that have not been used will roll over to this next fiscal year with a deadline of 12/31/2024 for all grant funds to be expended.

**SEARCH COMMITTEE REPORT:** Jon Blankenship reported there were 19 resumes received in the search for a new Executive Director. The Search Committee will meet today to narrow this down to a short list of candidates to interview.

**EXECUTIVE DIRECTOR REPORT:** Jon Blankenship, Interim Executive Director, asked Debbie Moore to give a couple of updates. Debbie reported the 2023 Annual Report has been printed and will be available to members at the October luncheon. They will be mailed to each ERDA business member as well. Debbie reported the logo for GCIA has been created by Kevin Friesen along with branding guidelines. This will help as we ramp up recruiting businesses to the industrial parks. Debbie also mentioned the OK Water Resources Board is beginning a series of public meetings requesting input on the State's water plan they are currently beginning to work on. Jon Blankenship reported Bri-Steel's Quality Jobs application was
